SCT MASTERCLASS WITH WILLIAM WHITAKER





Stubbing Court Training Ltd (SCT)'s apprentices and employers were given a rare opportunity to learn from one of showjumping's rising stars recently - William Whitaker. The final session in SCT's acclaimed Masterclass Series for 2013 took place on 15 November at Parklands EC, Sheffield. An impressive 45 of SCT's apprentices and employers took part in the Masterclass - William kindly taught all day from 9am to 5.30pm to give as many people as possible a chance to benefit from his knowledge. William, a former under-21 gold medallist and now a member of Britain's senior Nations Cup teams, said: "The SCT Apprenticeship programme gives great opportunities to young people who are already established riders to take their skills further, and also to the less experienced riders to get ideas and advice as to how to improve. The groups of riders I worked with had good attitudes - not just when things were going well, but also when things didn't go to plan, which I think is very important." All the participants went home inspired to further their training and improve their skills. "It was a very well planned day, and William was positive, encouraging and motivational," said one participant. "What a wonderful opportunity for the apprentices to have coaching from a trainer as well qualified as William Whitaker."

EMPLOYER SEMINAR - 14 OCTOBER 2013



SCT Ltd held an extremely well-received Employers' Seminar at the Twin Oaks Hotel, Chesterfield. Seventy of SCT's employers attended the day. They listened to four presentations, the first of which was by Spencer Moore, former Head of Strategic Development for British Swimming and a non-executive director of the British Equestrian Federation (BEF). He said: "In the end, all business operations can be reduced to three words - people, product and profits. Unless you've got good people, you can't do much with the other two."This ethos is at the heart of what SCT does; working to provide the horse world with well-trained, capable and positive young people and supporting both them and their employers in ensuring the working relationship is as beneficial as possible to both sides. He discussed the difference between "good" and "great" coaches and instructors, and advised employers on the capital funding available for equestrian businesses to develop. Mr Moore said that the BEF, which is the governing body for the Olympic equestrian sports in Britain, is keen to work more closely with SCT in 2014 and beyond. Keith Lawson from Peninsula Business Services gave an important update on employment law - key issues and legal requirements, including recent changes, and good practice. Anna Goodley from Lycetts Insurance Brokers talked about equine business insurance, and Sarah Hamlyn, an Ofsted inspector and one of British Eventing's regional directors, discussed best practice in training. Belinda Turner, SCT's chief executive, said: "We are excited to launch SCT's work with the BEF on innovations in coaching, safeguarding and equestrian facilities development, and delighted so many employers supported the Seminar.

BECKY PICKLES - APPRENTICE WITH WILLIAM WHITAKER

Becky Pickles, 16, is an SCT apprentice who has landed her dream job. She works for William and George Whitaker in their highly successful showjumping yard in Huddersfield. She travels with the horses to shows all over Europe she has recently been to Millstreet in Ireland and is off to Spain and Germany in the next few weeks. "I have always wanted to work with horses," says Becky. "But because I am young, it would have been very hard to get a job like this and I wouldn't have achieved it without being part of SCT's apprenticeship scheme. "I've always found it much easier to learn in a practical way, rather than just being handed a bit of paper at school, so an apprenticeship - where I learn on the job while getting amazing help and guidance from both the Whitaker family and SCT - is perfect for me." She says that working for members of showjumping's most famous family is inspiring. "You see how hard you have to work to do well and how important it is to pay great attention to every detail," says Becky. She thoroughly recommends becoming an apprentice, but warns: "You've got to really want to do it and to be prepared to work hard." Alison Whitaker, who manages the yard for her sons, says: "I wouldn't have picked just any 16-year-old to do this job, but I know that the apprenticeship scheme offers both Becky and us a lot of support and training." Alison's son George, double gold medallist and former winner of the "SCT Apprentice" of the Year" title, said "I wanted George to learn the



vitally important basics of best equestrian practice in a way that suited him, and the practical approach and support of the apprenticeship scheme worked extremely well for him".

SUMMARY OF MASTERCLASS FEEDBACK



Aspect 1: What was the most useful aspect of the day? • Knowledgeable trainer and good advice • Socialising my young horse • The warm up over the single jump and poles before and after the jump • Riding a different horse and applying different riding methods. It gives the apprentice a purpose to work towards. Preparing their horses, travel arrangements etc • Experience for my apprentice • Listening to William Whitaker telling his knowledge. Being able to jump a short course and receive feedback. Aspect 3: What will you do now to improve your work and progress? • Keep building horses confidence • Ride my horse positively • Try to find a school to hire so I can jump my own • Practice and work on my position and either holding or pushing for the strides • Apply different riding methods to different horses • I will carry on with and expand the lesson • More warming up time • Take my time when riding, look at what I can do to improve my course • Go home and practise what I have been advised to help me improve • Explain how the Masterclass has helped me in a diary sheet • Work on using the whole arena • Keep practising and keep up to date with my work • Carry on doing exercises as William advised • Keep work up to date and push myself harder • Use more poles • Keep the horses relaxed and slow down if needed • Work on my position like William said when at home, and do exercises similar to what I did today To approach jumps in a straight line and to use corners effectively
 More committed to practising jumping • Complete riding units 373, 375 & 376 • Keep training and be the best I can be • Keep pushing boundaries • Work on rhythm and corners • Continue to do as William advised • Keep my horse in a rhythm and sit up tall • I need to get more riding done and have a lesson in flatwork and more pole work - and get jumping! • Continue on the points suggested by William to improve my confidence • Carry on the way I am doing and continue with the course work • Grid work • Upload worksheets and diary sheets to moodle before assessor comes out so that she can talk through the work • Keep my approach calm and keep the horse quiet • Continue to work my horse in a rhythm and not allowing him to rush
